IPM statement

It is the goal of Big Oak Flat Groveland Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

- Eliminate significant threats caused by pests to the health and safety of students, staff and the public.
- Prevent loss or damage to structures or property by pests.
- Protect environmental quality inside and outside buildings, in playgrounds and athletic areas, and throughout Big Oak Flat Groveland School District facilities.

- Monitoring buildings for wasp and hornet activity by the site custodians. Any activity is reported to the IPM Coordinator.
